

**ZAMBOS® SUMMER FEST SWEEPSTAKES**  
**OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER THE SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. **PROMOTION PERIOD:** "The Zambos® Summer Fest Sweepstakes" ("Sweepstakes") begins at 10:00 A.M. Central Time ("CT") on 8/1/25 & ends at 11:59 P.M. CT on 8/31/25 ("Promotion Period").
